






#### STRATEGIC ACTIONS

#### **Leith Western Harbour Central Park**



Area: 5.2 Ha

# **Description:**

Open space proposal (OSR 2) identified in Edinburgh City Local Plan. The approved proposals for Western Harbour include a new park which will provide the facilities of a large neighbourhood park including formal and informal recreational facilities for all ages.

**Timescale:** The delivery of the park is proposed to be carried out in four phases. Phase 1 will ensure the implementation of

the northern section of the site where play areas will be located. Phase 2 and 3 will develop the eastern section and Phase 4 will complete the western section of the park.



# **Description:**

Open space proposal (OSR 3) identified in Edinburgh City Local Plan. The open space network proposed for Leith Docks includes a major new central park, proposed to be sited between two areas of water.



**Area:** 5.65Ha

# **Description:**

Open space proposal (OSR 7) identified in Edinburgh City Local Plan. The proposal would connect Leith Links to the sea and proposed Edinburgh promenade. Sports pitches, allotments and other open space uses would be laid out in a landscaped strip. A landscape design study has been prepared for this area.



#### **Leith Links**



**Area:** 18.78Ha

**Description**: Raise Park Quality Assessment grade from fair to good.

Park Improvement Plans are currently being developed for all Council owned parks. These examine previous PQA grades and set out recommended improvements on a range of issues prioritising them into short, medium or long term timescales.

Other corporate improvements in relation to pesticide use, information provision, signage installation and grounds maintenance are also being worked on.

**Timescales:** 2010 – 2020



# Disused Railway Network between Lochend Road and Seafield Road



Area: 1.9Ha

**Description:** The site is designated as a Local Nature Conservation Site. The proposed action is to improve the quality of the green corridor for recreation and habitat value. There is potential for a cycle link to the east.



# **Description:**

Site has been assessed to be of low quality. Enhancing its quality is a priority action as it will contribute to the Local Greenspace Standard by addressing a local deficiency.

The site is a small amenity space contributing to setting, views and residential outlook, situated off pedestrian link between Bothwell Terrace and Albion Street.






Edinburgh Promenade
Section F1-G2 Seafield and Marine Drive




**Section G2-G4 Leith Docks**

## **Edinburgh Promenade continued:**

## **Description:**

The promenade will form a continuous walkway/cycleway extending for almost 17km from Joppa in the east to Cramond in the west.

The Promenade will link communities along the coast with each other and with adjoining communities providing a safe and attractive corridor for pedestrians and cyclists. Along the route a number of nodes will be developed that will act as destination points offering opportunities for recreation and entertainment facilities. The route of the promenade has been safeguarded and a design code has been adopted by the Council to support its development.

Within Leith NP area part of the promenade has been constructed within Western Harbour however the remainder of the promenade will require to be constructed.

**Timescale**: The promenade will be developed in phases over a long timeframe. It is estimated that the sections within Leith NP will be complete by 2038.



# Powderhall and/or Abbeyhill Railway



# **Description:**

New green corridors linking to Lochend Park and the Water of Leith from Abbeyhill/Meadowbank, subject to future requirements for the Powderhall and/or Abbeyhill loop railway lines. Identified as a transport safeguard in the Edinburgh City Local Plan. Green corridor to the west of Abbeyhill to be delivered through the Lochend Butterfly Project.

Timescale: Subject to agreement with Network Rail.



# **North Edinburgh Paths**

# **Description**


This is a network of paths with several branches, all of which follow disused railway lines. The Roseburn to West Granton Road corridor is planned to be used for the tram project. This section is to be upgraded subject to dualling with Tram line 1B. This would provide pedestrian and cycle access alongside the tramway.

Timescales: unknown

Funding source and cost: to be determined

# **Pilrig Park Allotment Extension**



Area: 0.6 ha

**Estimated Capacity: 30 plots** 

**Description:** One of the initial sites identified for potential use as allotments. The area is currently an accessible part of Pilrig Park and this would be an extension to the existing allotments.


**Timescales:** The most appropriate allotment sites will be included in the 5 year Allotment Site Development Programme to be prepared in late 2010.

Programme to be prepared in late 2010.
